#### Roles and responsibilities

The management of SUPERALLOY is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

- The IPCC 2021 AR6 GWP values are applied in the inventory.
- GHG information for the following period was verified on 2025-03-19 to 2025-04-22.
